If the bales are not removed from the roadside immediately after bailing, the R.M. of Wallace-Woodworth may remove the bales at the expense of the applicant responsible for mowing the right-of-way(s).
	C. All approved applicants must have the roadside mowing of their approved right-of-way(s) complete by August 1 st each year.
	D. Any individual harvesting roadside vegetation assumes full liability against accident or injury to themselves, their staff, or the general public at any stage of the harvesting procedure.
	<u>OTE:</u> The R.M. of Wallace-Woodworth may suspend future roadside mowing privileges of persons not mplying with these conditions.
